The UNITAR South Sudan Fellowship Programme

This first launched in 2015 with the support of the Government and People of Japan, and it became an annual programme thereafter. This programme targets junior-to-mid career level professionals from the government, civil society organizations, private sector, media organizations, and academic institutions of the Republic of South Sudan. The participants, referred to as Fellows, are selected through a highly competitive process and go through the six-month-long training that focuses on knowledge, skills, and attitudes needed for effective project management, youth leadership, and social entrepreneurship, aiming to develop the individual capacity to become a leader in their respective organization to contribute to the sustainable recovery and development of their country.

This programme also encourages peer learning, knowledge sharing, and the formation of a network of like-minded colleagues and friends across all sectors.

The programme consists of four workshops through which each Fellow learns to identify local needs and national priorities, design and implement projects effectively, and develop a project proposal that addresses contemporary challenges and problems. The proposal serves as an action plan for implementation upon completion of the programme.

A special emphasis is placed on methodology and skills development related to leadership and mentoring. Learning about entrepreneurship and social entrepreneurship is balanced with training on the provision of good public services, so that Fellows will be equipped with tools to work in a variety of environments in South Sudan, including those where entrepreneurship may not be viable.

Upon a successful completion of the training programme, Fellows are believed to be capable of designing and implementing projects in ways that will help shape their nation's future path.

Expert Support

The staff of UNITAR, as well as an international network of Resource Persons and Mentors, are continually engaged with the programme and support the Fellows through sharing their knowledge and experiences and by providing advice and feedback.





Several standout Fellows are selected to act as coaches for the following cycle. They receive additional training and play a key role in contextualizing the learning of the programme to the changing situation in South Sudan as well as guiding the new Fellows through the programme's milestones. Many Fellows find them very helpful as they also went through the training and know the background situation of their own country.



Hiroshima, Japan

Workshop III is held in Hiroshima, a city known as the City of Peace. Hiroshima experienced the tragedy of the world's first atomic bombing and recovered from the devastation with the help of local citizens, as well as people from other cities and countries. The city dedicates itself to promoting peace globally and has many experiences and lessons to share.

Having Hiroshima as one of the workshop sites inspires Fellows and gives them hope for South Sudan's recovery. The story of Hiroshima's atomic bombing and recovery, in addition to Japan's post-war reconstruction, has a very powerful impact on the Fellows.

Two Cycles Successfully Concluded

Since the programme's initial launch, both the 2015 and 2016 cycles have successfully concluded; there are now 45 total graduates of the programme. Fellows' feedback has been positive, highlighting the relevance of the training contents to their fields of work and the effectiveness of the trainers and methodology in achieving the learning objectives.

Upon completion of the programme, Fellows delivered training sessions within their own organizations, sharing the experience and key lessons with their peers. The network of alumni in South Sudan is growing and is a valuable resource to both future Fellows and their local counterparts.
