## Flagship Projects

### Online Master Degree Programmes

UNITAR's Master degrees, offered in collaboration with prestigious higher education institutions, are specialised academic programmes crafted to enhance knowledge and capacities in peace and security, aligning with SDGs 4, 16, and 17 for sustainable development. Delivered primarily online, these programmes cater to mid-to-upper-level professionals, offering flexibility for those currently working in the field or involved in extensive travel. Comprising modular components adaptable to individual preferences, these advanced academic modules contribute directly to capacity-building, enabling participants to contribute significantly to sustainable peace.

The impact of our (Online) Master Degrees, certificate, and diploma programmes extends beyond individual capacity-building, influencing stakeholders and institutions dedicated to peacebuilding. Emphasizing community involvement, these programmes equip learners with tools and knowledge, ensuring a positive impact on various interventions. Aligned with SDGs, our programmes aim to develop expertise and frameworks, contributing to lasting peace. Prioritising the UN's Our Common Agenda and UN 2.0 vision, UNITAR strives to empower professionals and institutions, fostering positive change and sustainable peace globally.

### Open Online Courses

The free and open online courses are a great choice, and opportunity, for anyone willing or needing to get familiar with the basic concepts and topics in the areas of conflict, peace and security as well as other thematic areas addressed by the SDGs, including but not limited to gender equality (SDG 5), climate action (SDG 13) and peace, justice and strong institutions (SDG 16). The 25 self-paced courses are for anyone seeking fundamental insights that span diverse themes from trauma and gender to conflict analysis and resolution. Offered in English, French, and Spanish, these courses do not require prior knowledge. The MOOCs aim to deliver an inclusive and quality learning experience, aligning with SDG 4 for inclusive and equitable education. Participants gain tools to analyse, understand, and explore concepts and frameworks within diverse themes, fostering engagement through creative asynchronous methods.

### UNV Online Courses

This joint project was developed and is implemented by UNITAR and the United Nations Volunteers Programme (UNV). It offers all assigned UN Volunteers the opportunity to take part in a series of courses on topics ranging from Women, Leadership and Peacebuilding to Electoral Security and Conflict Prevention. These self-paced online courses provide in-depth insights and advanced knowledge meant to develop professional skills and key competences in the areas of gender, conflict, peace and security, environment, and mental health. The programme, therefore, aims to enhance the knowledge and skills of all UN Volunteers as part of their learning journey, as well as to present some important frameworks and tools in areas relevant to the fulfilment of their responsibilities while in deployment.



"I am currently enrolled for a Master's in Electoral Policy and Administration (MEPA). For seven (7) years I worked with local Civil Society Organizations in West Africa to issue grants to promote country-specific electoral security programmes. To enhance my knowledge on Electoral Security, I came across the MEPA programme which is very flexible for my work schedule.
