## Flagship projects

### Strengthening the Capacity of the Judicial System and Promoting the Rule of Law in Mali

UNITAR has been supporting national stakeholders in a comprehensive reform of the judicial system as part of Mali's governmental transition. The project strengthened and modernised the Malian judicial system, particularly in its institutional desire to promote the rule of law and ensure efficient and accessible justice institutions.

UNITAR and its partner, the Institut National de Formation Judiciaire (INFJ) conducted a wide range of training courses targeting different groups of actors. In total 1.645 beneficiaries from the legal system, civil society and media benefitted from tailored training in their respective work areas.

UNITAR seeks to continue the successful cooperation with the INFJ in future projects.



## Future projects

The success of the project in Mali became known in the region. UNITAR has started to develop rule-of-law and justice projects in West Africa. They serve to support reforms and efforts of governments in improving the functioning of the country's justice system. Targeted measures will contribute to ensuring that justice systems will gain in accessibility, legal certainty and legitimacy for the benefit of the population. They will also respond to the aspiration of legal actors to ensure a quality of work at the highest professional level.

### Senegal:

UNITAR is developing a project aiming at strengthening the capacities of legal actors in cooperation with the *Centre de Formation Judiciaire* in Dakar.

### Niger:

#### • Fostering the rule of law and justice in Niger

- A project strengthening the capacities of the various actors offering conflict resolution and legal advice outside the Nigerien formal justice system is being developed.
- In a separate project, UNITAR seeks to build the capacities of the *Ecole de Formation Judiciaire du Niger* by supporting training in various legal subject matters.
