QCPR (A/RES/71/243)

(of operational activities for development of the United Nations system)

• Q = quadrennial = 4 years

Resolution discussed every four years in the second committee of the General Assembly (2012, 2016, 2020, before 2012 it was TCPR (3 yr)), but the follow-up of its implementation is done yearly in the ECOSOC OAS (operational activities segment) resolution. The Second committee also has a yearly resolution on the QCPR, mostly procedural or to bring the ECOSOC updates into the GA.

• C = comprehensive = all UN development, but...


Should cover all aspects of operational activities for development of the United Nation system. More than 30 UN entities (funds and programs, specialized agencies) are active in development. UNSDG (United Nations Sustainable Development Group) or UNDS (United Nations development system, generic name, no official list of members) are usually considered as the operational activities for development of the United Nation system.

• P = policy = strategic, but...

The resolution focuses on the policy level. It gives guidance on how the UNDS should work and includes some normative elements that are valid for all (Agenda 2030). The resolution gives also practical guidance that are more specific than a policy! It has become a mix of strategic and policy level and more operational aspects.

• R = review = accountable

The resolution builds over the years and is based on thorough reviews made by UN DESA (SG reports). It has a review mechanism (ECOSOC annual resolutions) that is based on annual SG implementation reports.




Role and responsibilities

- Mandatory for Funds and Programmes and other entities that depend on the GA (UNDP, UNICEF, UN Women, UNFPA, UNOPS, UNEP, WFP, ITC, UNCTAD, UN Habitat, UNHCR, UNRWA)
- Specialized agencies are strongly encouraged to follow it as well (FAO, WHO, ILO...)
- DESA does the follow-up reports (monitoring and reporting framework)
- Each fund and programme should include in their yearly report to their boards the progress on the implementation of QCPR.
- The role and behavior of Member States in the different organs and bodies of the UNDS should be consistent with the QCPR.

Why is QCPR important ?

- QCPR asks the UNDS to function as a system (collaboration, coordination, efficiency, division of labor...), and not independent actions.
- QCPR helps government to have a unique UN interlocutor (RC) to implement the Agenda 2030 through a united framework (UNSDCF) and system-wide guidance and knowledge sharing
- QCPR gives guidance for the strategic plans of the funds and programs and is in line with eth High Level political Forum (HLPF)
- 4 years cycle and cascade
 - 2015: Agenda 2030, every 4 years HLPF GA (2019, 2023)
 - 2016 2020 2024: QCPR
 - 2017, 2021 : approval strategic plans 2018-2021/ 2022-25 of Funds/Progams

QCPR: SG to present a comprehensive proposal to strengthen Resisdent Coordinator system at the GA72 (OP 58)

- → Predictable Funding (OP10)
- → Creating DCO (OP 17)

 \rightarrow Implementation Plan

- QCPR: Introduce or strengthen knowledge Management strategies and policies (OP 70) Res 72/279:
 - → Address gaps and overlaps at the regional level, Options for reprofiling and restructuring the regional assets (OP 19)
 → Regional Review
- QCPR: The Agenda 2030 requires a more sustainable funding approach (OP 25-43) Res 72/279:

- QCPR: SG to present a system-wide strategic document ... to support the implementation of the Agenda 2030

Some challenges of UNDS

- Fulfilling the Agenda 2030 is beyond development activities
- Implementing the Agenda 2030 which trade-offs between the SDGs
- Implementation of the UNDS Reform
- Implementation of the System –wide Strategic Document
- Further improve the governance structure
- Live up to the agreed Funding Compact
- Response to the COVID 19 crisis
- Nexus work between development, humanitarian and peace building?

Can the QCPR alone address all those challenges?

10-15 year vision: Interesting role of the ongoing ECOSOC dialogue on the longer term positioning of the UNDS and its influence on the next 3 or 4 QCPR (each 4 yr).
