1. 77<sup>th</sup> session from Tuesday, 13 September 2022. Basic information in the daily Journal (copied in the box below). The session is expected to close on Tuesday, 5 September 2023, by 1 p.m.

(Journal/General Information/ General Assembly: seventy-sixth session)

The seventy-seventh session of the General Assembly will commence at United Nations Headquarters on Tuesday, 13 September 2022.

The provisional agenda of the seventy-seventh regular session of the General Assembly is contained in document A/77/150.

The annotated preliminary list of items to be included in the provisional agenda of the seventy-seventh regular session of the General Assembly is contained in document A/77/100.

The list of supplementary items proposed for inclusion in the agenda of the seventy-seventh session of the General Assembly is contained in document A/77/200.

A draft programme of the work of the plenary for the seventy-seventh session is contained in document A/76/903.

The information note for delegations on the arrangements for high-level meetings and the general debate of the seventy-seventh session of the General Assembly was issued in document A/INF/77/4.

Seating protocol for the seventy-sixth session

On Tuesday, 7 June 2022, the name of Belize was drawn from among Member States to occupy the first seat in the General Assembly Hall at the seventy-seventh session. Consequently, the delegation of Belize will sit at the first desk at the right of the President, and the other countries will follow in the English alphabetical order. The same order will be observed in the Main Committees.

General Debate

The general debate will open on Tuesday, 20 September 2022 (A/INF/77/1).

The provisional list of speakers for the general debate (20 to 24 and 26 September 2022) was sent to the permanent missions on 18 July 2022.

Delegations are kindly reminded that, in accordance with established practice, each statement in the general debate should be limited to 15 minutes in order to accommodate speakers for each meeting in a timely fashion. The list of speakers for each meeting is built on this voluntarily agreed time limit.

The theme "A watershed moment: transformative solutions to interlocking challenges" has been proposed for the general debate at the seventy-seventh session, pursuant to General

Assembly resolution 58/126, Annex (A letter from the President of the General Assembly, dated 29 June 2022, was sent to all permanent representatives and permanent observers).

## 2. First week

<u>Monday, 12 September (11:30 a.m.)</u> (Closing of the 76<sup>th</sup> session will include the statements by the SG and the outgoing PGA, one minute of silent prayer or meditation, the oath of office of PGA-77 and the hand-over of the gavel)<sup>1</sup>

Resolution 70/305, OP 57: "Decides that the President-elect of the General Assembly shall take an oath of office of his or her own, as detailed in annex I to the present resolution, at the moment of handing over the gavel in the final plenary meeting of the preceding session, and decides that the text of the oath shall be annexed to the rules of procedure of the Assembly"

### Annex 1 – Oath of Office:

"I solemnly declare that I shall truthfully perform my duties and exercise the functions entrusted to me as President of the General Assembly of the United Nations in all loyalty, discretion and conscience, and that I shall discharge these functions and regulate my conduct with the interest of the United Nations only in view and in accordance with the Charter of the United Nations and the code of ethics for the President of the General Assembly, without seeking or accepting any instruction in regard to the performance of my duties from any Government or other source external to the Organization".
