UNITAR was created in 1963 to train and equip young diplomats from newly-independent UN Member States with the knowledge and skills needed to navigate through the diplomatic environment. We have become a leading institute in the provision of customized and creative learning solutions to institutions and individuals from both public and private sectors. # UNITAR's Work in Multilateral Diplomacy

At the heart of UNITAR, the Division for Multilateral Diplomacy aims at strengthening the intergovernmental machinery of the United Nations by providing training and capacity-building activities that address the needs of diplomats, government officials, international civil servants and private sector specialists to meet complex and global challenges. UNITAR's Division for Multilateral Diplomacy activities cover a wide range of policy domains including international law, multilateral negotiation, environmental and climate change diplomacy, human rights, artificial intelligence, economic diplomacy, human rights, Agenda 2030 and other related topics, as well as capacities and skills development activities such as leadership, diplomatic report writing, public speaking, media relations and negotiation techniques, among many others. The trainers and resource persons selected by UNITAR for the different training activities are experts in various fields of multilateral diplomacy, international affairs and international law, including practitioners from both within and outside the United Nations system.

### 1963

UNITAR was founded in 1963 based on the recommendation of the UN Economic and Social Council to the General Assembly. The Secretary-General then established the United Nations Institute for Training and Research, as an autonomous body within the UN system.



### 1968

UNITAR expanded its training activities under the leadership of Chief S.O. Adebo of Nigeria, including the establishment of regional training seminars to train junior diplomats from the Global South, and the launch of fellowship programmes.



### Today

UNITAR's mission is to develop the individual, institutional and organizational capacities of countries and other United Nations stakeholders through high quality learning solutions and related knowledge products and services to enhance decision-making to support country level action for overcoming global challenges. In pursuing our mission, we place priority value on ensuring that our knowledge and related products and services are client-oriented, modern and innovative, and that they meet internationally recognized quality standards.



## Customized Trainings

- Upon the request of UN Member States and/or in partnership with intergovernmental organizations, UNITAR designs and delivers tailor-made activities on themes related to multilateral diplomacy, international affairs, international law and skills development
- The duration, content and structure of the courses are defined in close consultation with the beneficiaries, governments and partner organizations in order to meet their specific needs
- UNITAR's customized training activities can be implemented face-to-face (in Geneva, in the beneficiary's country or in another city relevant for the course), online or hybrid
