Pilot Course on Addressing Mis- and Disinformation in Peacekeeping Operations



WHAT?

In response to the proliferation of mis-disinformation facilitated by modern information technologies, the pilot course aimed at validating the recently developed Reinforcement Training Package, emphasizing the critical role of Strategic Communications (StratCom) in shaping perceptions of UN missions.

The pilot course, developed by the Integrated Training Service (ITS) of the Department of Peace Operations (DPO), aligns with UN Action for Peace Plus (A4P+), prioritizing StratCom to counteract the manipulation of public opinion and delegitimization of UN activities. Recognized at the recent UN Peacekeeping Ministerial, the course fulfills the need for cultural change within missions, empowering leaders to see StratCom as a strategic asset and equipping experts with modern capabilities to confront mis-disinformation effectively.

WHO?

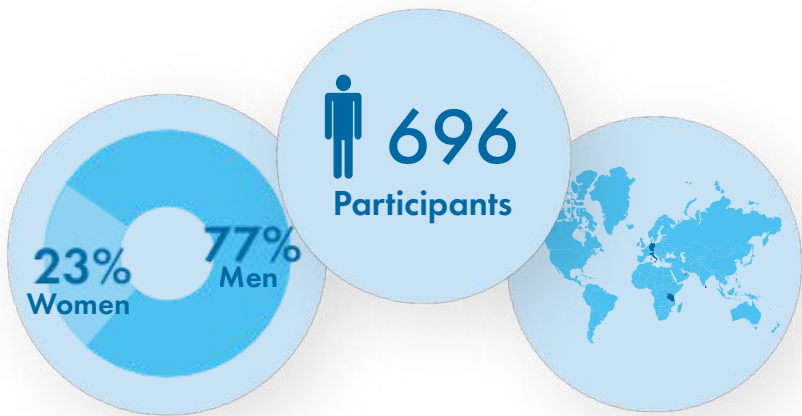
The initiative was directed towards experts in Mis-dis-mal-information and hate speech (MDMH) to validate the content of the course.

Participation in the pilot course was funded by internal resources of the Pre-Deployment Training and Advisory team. A broader proposal complementing the UN Secretariat's efforts is being submitted for funding, showcasing the potential impact of collaboration on the organization's goals.

Pre-Deployment Training and Advisory

Military and police pre-deployment training

WHAT?

The pre-deployment training of military and police personnel is vital to enhance mandate implementation in peacekeeping operations. Aligned with General Assembly Resolution 49/37, this project addresses Member States' responsibility to improve performance through comprehensive training. By equipping personnel with the necessary skills and knowledge, it ensures effective adaptation and capability enhancement. The training fills a critical need by preparing peacekeepers to navigate complex operational environments, fostering a culture of preparedness and professionalism. It encompasses a range of components, including political, physical, and programmatic aspects, empowering personnel to fulfill their mandates effectively and contribute positively to peace and security efforts worldwide.

WHO?

The training addresses military and police personnel from Troop and Police Contributing Countries (T/PCCs) prior to deployment to peace operations.

The focus group sessions were conducted in collaboration with *Corporación Dimensión Génesis*. The results obtained will inform future partnerships with key strategic partners in Colombia, such as Comfama, the UN Verification Mission, the EAFIT University and Chamber of Commerce of Medellín.

WHAT?

Committed to SDGs 5 and 16 recognizing the unique roles that women play in the peaceful transformation of conflict affected societies, UNITAR is joining efforts with strategic partners in Colombia to [scale the successful model of the Women's Leadership for Peace Programme](#).

To better understand the lived realities of women leaders at different levels of the Colombian society, UNITAR in January conducted two focus group discussions with women leaders from rural communities in Antioquia. [The results reflected the complex needs, desires, and challenges that women face in realizing their full leadership potential](#). A specific focus was placed on the intersection between peaceful change within rural contexts and women's leadership in the domains of biodiversity and environmental sustainability.

Resulting recommendations for future programming therefore included the [strengthening of capacities of women leaders in key thematic areas](#), the [enhancement of support networks to collectively drive progress and pathways to include men in women's leadership](#).

WHO?

WHAT?

The event addressed the critical education challenges faced by countries affected by armed conflict in Africa, within a broader project that aims to strengthen African Union Department of Political Affairs, Peace & Security (DPAPS) support to regional and national conflict prevention processes through human rights-informed early warning systems. Education is a fundamental human right and plays a pivotal role in breaking and preventing cycles of violence.

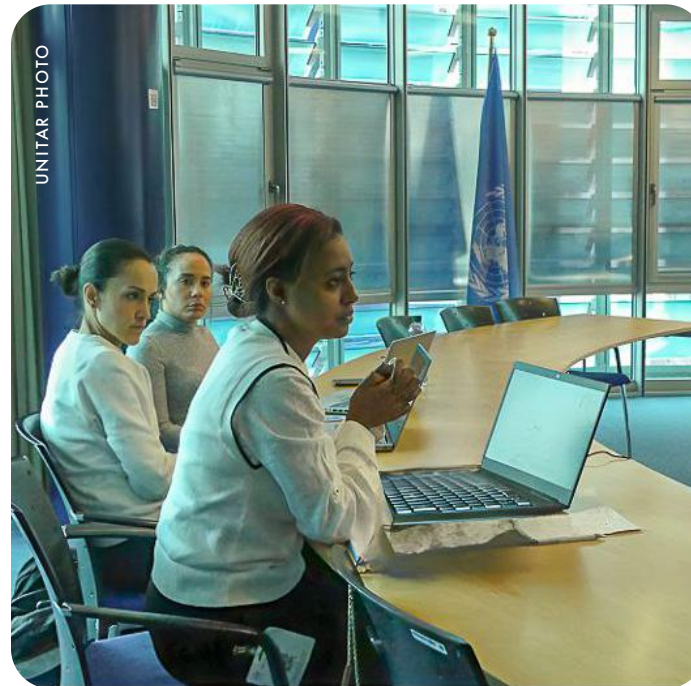
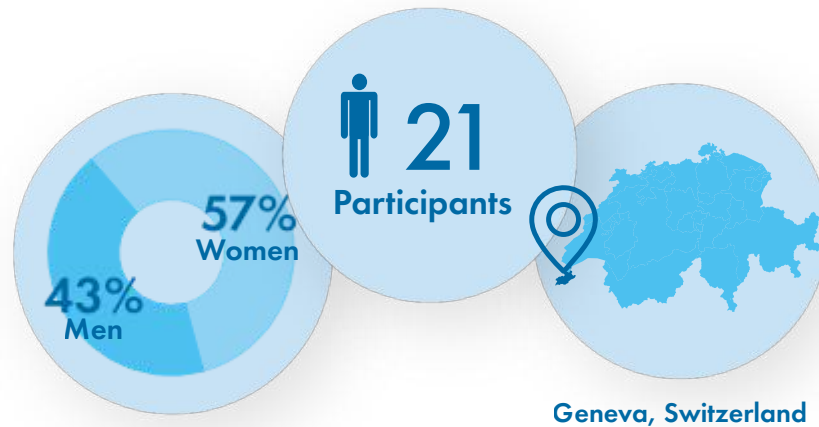
The event made a significant difference by not only focusing on education but also incorporating early warning systems to proactively identify and address conflicts before they erupt. By leveraging human rights-informed early warning mechanisms, the main project enhances its ability to anticipate and respond to emerging threats to peace and security.

The side event was part of the UK FCDO funded joint African Union United Nations and World Bank programme "Strengthening Operational Linkages between Early Warning and Conflict Response" (2023-2025) which includes awareness raising, advocacy, and capacity building activities as well as research initiatives, all aimed at strengthening the African Union Political Affairs, Peace and Security Department (DPAPS) support to regional and national conflict prevention efforts. By incorporating early warning mechanisms, the programme enhances the African Union's ability to identify and respond to potential conflicts in a timely manner, thereby contributing to sustainable peace and development in the region.

WHO?

This event provided a platform for key stakeholders to convene, share insights, and strategize on addressing the critical issue of education, conflict prevention and peacebuilding in Africa, i.e. representatives from the African Union, member states, think tanks, United Nations agencies, the World Bank Group, academia, and African training centers.

"Strengthening Operational Linkages Between Early Warning and Conflict" African Union - World Bank - United Nations Joint Programme – Technical Meetings (11-12 March 2024)



WHAT?

The event was part of the UK FCDO funded joint African Union, United Nations and World Bank programme "Strengthening Operational Linkages between Early Warning and Conflict Response" (2023-2025) to strengthen the collaboration among partners. The two-day event, which included a panel discussion event and a series of technical meetings, focused on the key role of human rights in conflict contexts, exploring how adopting a human rights approach on conflict prevention and response can support the success of both early warning systems and Disarmament, Demobilization and Reintegration processes – and ultimately contributing to stabilization and sustaining peace.

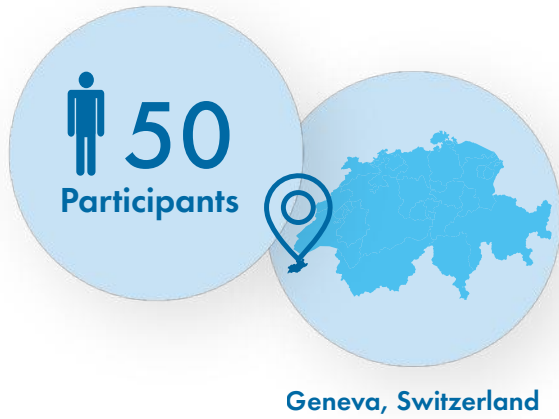
The two-day event helped identifying, through peer-to-peer exchange, relevant experiences and concrete examples and lessons learned in the areas of data collection and analysis and linkages to early warning systems, to assess the root causes of conflict and preventing and interrupting the cycle of violent conflict in Africa.

WHO?

The two-day event saw the participation of the project partners, UNITAR, the World Bank Group, the African Union (AU), the Office of the High Commissioner for Human Rights (OHCHR), the Department of Peace Operations, the UN Office to the AU, the Institute for Peace and Security Studies (IPSS), as well as representatives from the Colombian Agency for Reincorporation and Standardization (ARN) and from the Disarmament, Demobilization, Community Recovery and Stabilization Program of the Democratic Republic of Congo (P-DDRCS).

WHAT?

Building on the Colombian experience of conflict and peace, UNITAR, the African Union, the World Bank Group, and the Colombian Permanent Mission to the UN, organized a side event to the 55th session of the Human Rights Council, to promote cooperation between Member States, international and regional organization on conflict prevention and response, in particular in a moment when violent conflict across Africa is highest in decades.

The one-hour panel event provided an opportunity for the sharing of knowledge and experience, especially from Colombia and the Democratic Republic of Congo. Emphasis was on linkages between reintegration processes, human rights, and early warning systems to address conflict root causes and interrupt and prevent cycles of violent conflict. The diverse group of panelists featured contributions from: the African Union, civil society organizations, the Colombian the Agency for Reincorporation and Standardization (ARN), and the DDR Community and Stabilization programme of the Democratic Republic of Congo.

WHO?

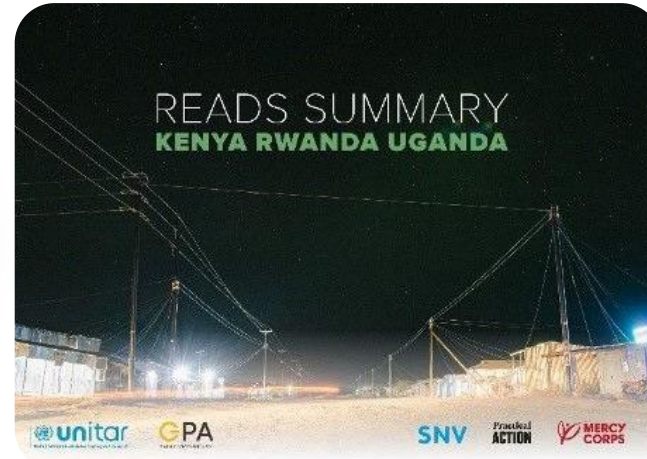
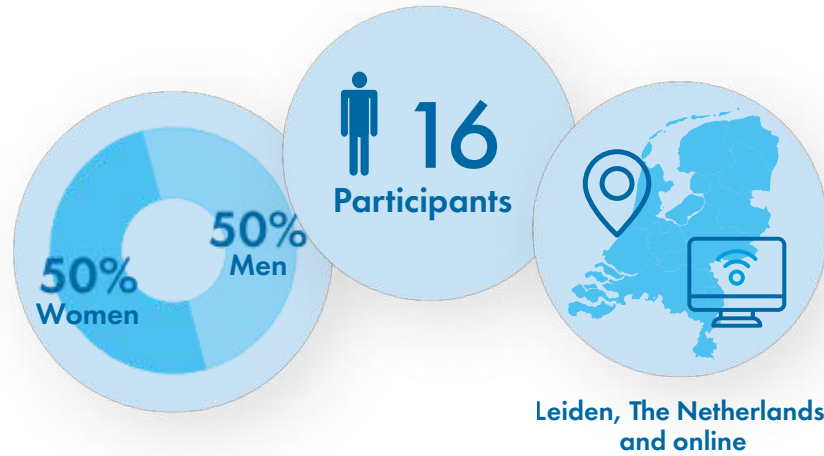
The event saw the participation of 50 representatives of Member States and UN Institutions. A total of 16 countries, besides Colombia and DRC, were represented: Angola, Australia, Belgium, Chile, Dominican Republic, Ethiopia, France, Germany, Ireland, Italy, Portugal, Spain, Switzerland, Togo, Turkey, USA.

Sustainable Energy READS Donor Engagement Workshop 2024



WHAT?

The Roadmaps for Energy Access in Displacement Settings (READS) project organized a workshop that was co-hosted by its funder, the [IKEA Foundation](#). The workshop brought together a select group of donors and was held at the IKEA Foundation's office in Leiden, the Netherlands. The objective of the workshop was to promote opportunities to support and scale up energy access interventions in displacement settings in East Africa, present project concepts that were developed by the READS project and gain a deeper understanding of donors' current activities and priorities related to energy in contexts of forced displacement.

The READS project also produced a summary report that presents the main findings from the READS project on enhancing sustainable energy access for refugee and host communities in Kenya, Rwanda, and Uganda. The summary reports were presented at the donor engagement workshop.

WHO?

The workshop targeted a select group of institutional and philanthropic donors who worked on the topic of energy access in East African countries. The total number of participants was around 16 participants including donors, project partners, refugee representatives and the UNITAR team.



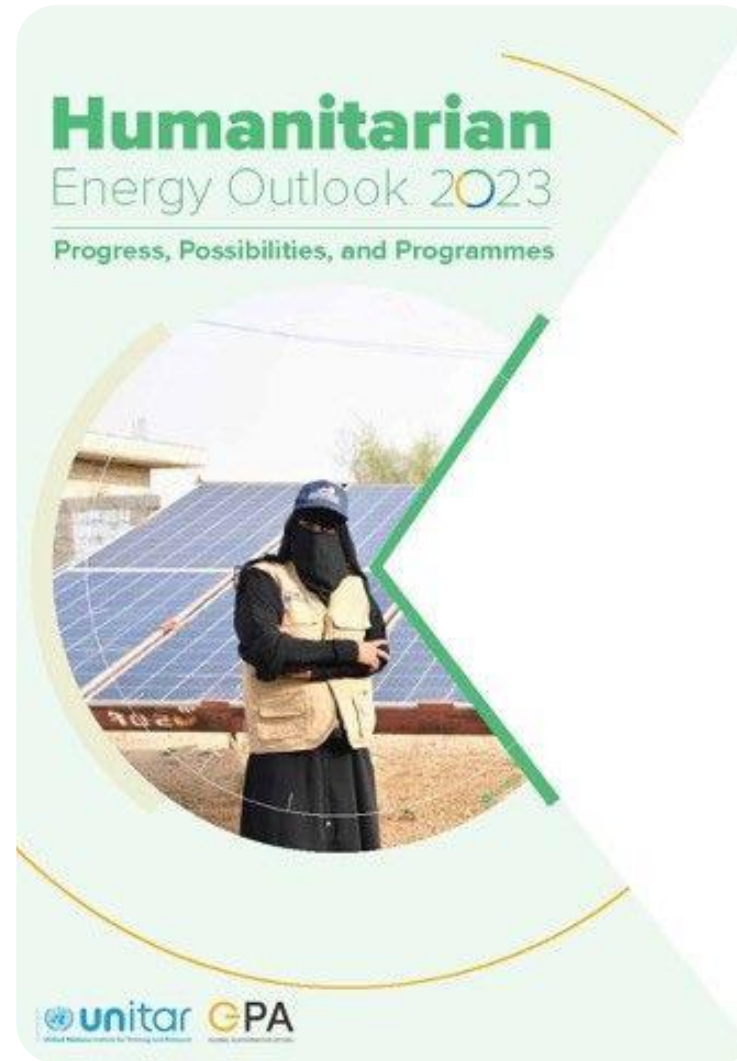

Sustainable Energy Humanitarian Energy Outlook (HEO) 2023



WHAT?

The Transforming Humanitarian Energy Access (THEA) project provides inclusionary analysis and evidence on the energy needs of all displaced people, specifically by delivering high-quality research and knowledge to support policy and decision-making on humanitarian energy investments and enabling systematic change within the UN system and humanitarian partners.

The THEA project has produced the Humanitarian Energy Outlook 2023 that emphasizes the need for stronger strides towards SDG 7 and achieving net-zero emissions in displacement contexts. It also urges for enhanced commitment, collaboration, innovation, research, and funding to ensure equitable sustainable energy access for all displaced persons.

WHO?

The Humanitarian Energy Outlook aims to engage governments, NGOs, international organizations, and the broader public to recognize the urgent and continuous need for action to enhance the well-being of displaced individuals. The report also serves as a strategic tool to inform the humanitarian sector about energy provision and access for displaced people and help the sector track energy progress to ensure refugees are not left behind in the global agenda of SDG 7.

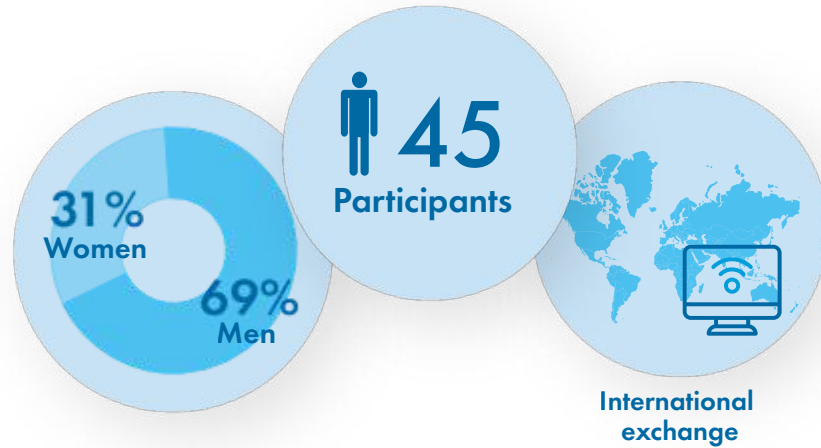

Peacemaking and Conflict Prevention

Knowledge Exchange Among Special Representatives of the Secretary-General



WHAT?

The Secretary-General has called for a "surge in diplomacy for peace", and for a return to the UN Charter, and on the peaceful resolution of disputes. His Special and Personal Representatives and Envoys heading peace missions and operations around the world, work with parties towards the negotiation and mediation of political solutions to prevent and sustainably resolve conflict to build more peaceful, just and inclusive societies.

Given the challenges facing the international community and leaders of the peace and security architecture, it is important to have opportunities to exchange ideas and practice. Working closely with the Executive Office of the Secretary-General and Departments, the Institute organizes a regular exchange. In 2024 this provided a unique opportunity for the heads of departments, missions and operations to share knowledge, experience, and lessons with the purpose of enhancing practice. Very positive feedback has been received, including from new heads of mission who found the peer-to-peer exchange informative and inspiring, and from another official who called this a historic opportunity to share among colleagues at this time.

WHO?

The 2024 sharing of knowledge and experience among officials was organized with the participation of 45 people around the world including heads of missions and operations and departments. The regular exchange provides a unique opportunity to identify challenges and emerging trends, and to share strategies and lessons with the purpose of enhancing practice.

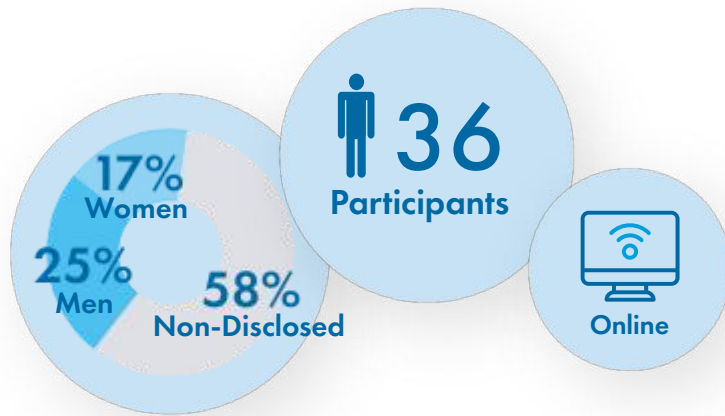
Departmental Heads of Mission discussions also took place with the participation of 30 men and 13 women.

WHAT?

The online Master in Electoral Policy and Administration (MEPA) provides advanced learning on electoral processes for current and aspiring election professionals through a network of field practitioners and world-leading academics and electoral experts. Responding to a global structural demand for qualified electoral professionals, the programme is based on a systematic and comprehensive approach to the professional development of those enrolled and places particular emphasis on the importance of advancing equal career opportunities for men and women in this sector, including in senior positions.

The programme has enhanced electoral stakeholders' leadership, conflict, and quality management capacities and contributed to the digitalization of electoral processes. Since its inception, it has provided a dynamic and interactive platform where election professionals have deepened their knowledge and developed their skills surrounding several topics within the framework of the electoral process. Furthermore, it is delivered in English, French, Portuguese, and Arabic equipping stakeholders with the necessary competencies to improve the operational effectiveness of policymakers and decision-makers in elections.

WHO?

The Master's diploma focuses on the development of electoral professionals, i.e., professionals who share a common set of norms, behavioral standards, and qualifications to assume specific roles and responsibilities in the area of electoral policy and administration.

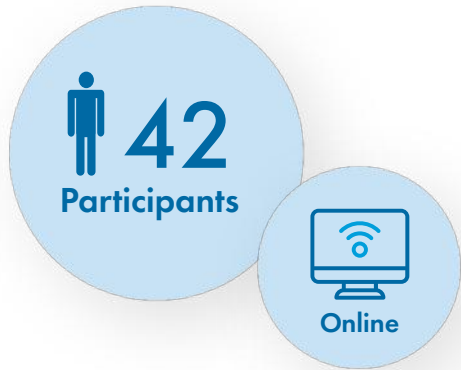

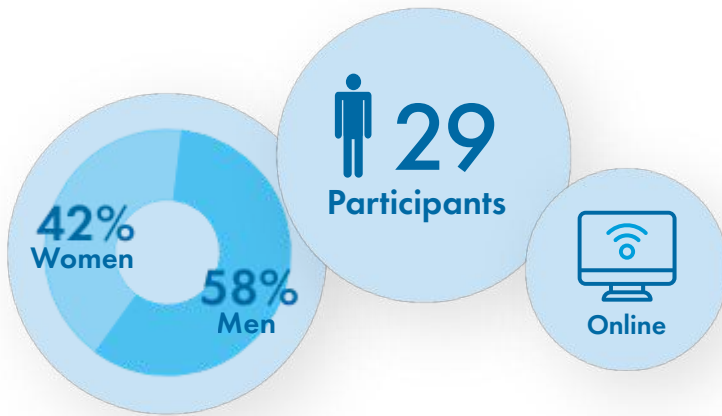

WHAT?

The Master in Conflict, Peace and Security, offered in partnership with Universitat Oberta de Catalunya (UOC), equips learners with a broad analytical skillset, first-hand knowledge and unique expertise from the field, under the auspices of SDG 17 to **strengthen the means of implementation and revitalize the Global Partnership for Sustainable Development**. Bringing together both academic and practice-oriented perspectives, the Master's programme has been designed to cover all important aspects of the settlement, resolution, management, and transformation of conflicts as well as **peace and security studies insights**. It therefore represents a valuable resource for all individuals working or aspiring to work in this specific domain by linking applied knowledge and practice with theory through online learning, sharing of experiences and discussions with key practitioners, and critical reflections.

The aim of the programme is to support its graduates with solid knowledge and the ability to handle the most complex challenges that the profession presents, in particular in the wider context of conflict and post-conflict environments. It is strongly based on real-life experiences and is meant to allow learners to reflect as much as possible on their current professional practice. It is conceived as an international Master's programme that aims to foster durable relationships between graduates from different parts of the world.

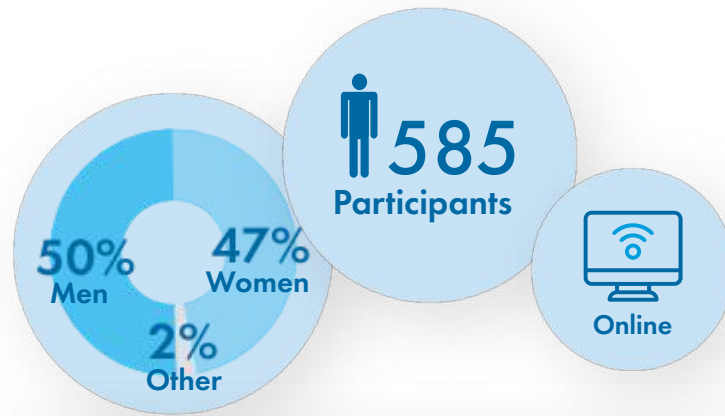
WHO?

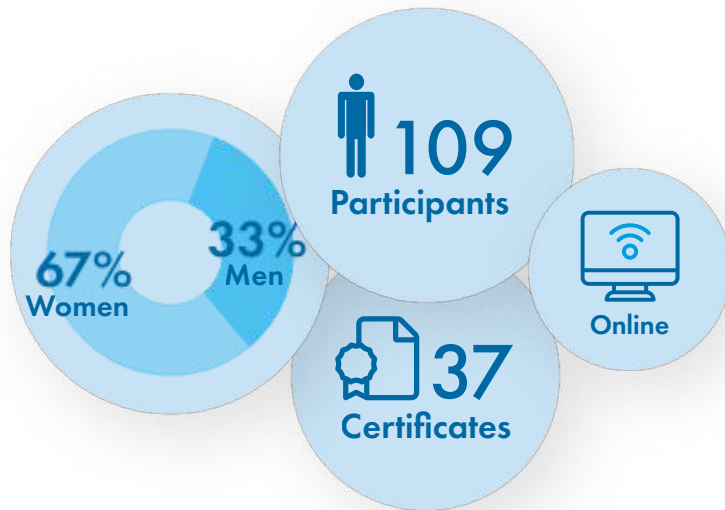

Supporting the Malaysian Coast Guard for Improved Maritime Surveillance (Phase I)



WHAT?

The project aims to help strengthen the capacities and capabilities of Malaysian Maritime Enforcement Agency (MMEA) and other national maritime stakeholders in the context of Maritime Security, as a reaction to maritime security challenges in the region such as piracy and illegal, unreported and unregulated (IUU) fishing.

Phase I, which will last until April 2024, will be to carry out various fact-finding missions to the Malaysian maritime authorities with a view to proposing a Phase II for 2024 and 2025. The main objective of Phase II will be to provide the MMEA with additional optical drones, coordination of the drone unit in the establishment plan, as a professional unit responsible for monitoring and carrying out actions in port areas, coastal waters and on the high seas to enforce laws and regulations. The project also aims at improving interagency and regional cooperation and the delivery of tailored maritime security training, as requested by MMEA.

WHO?

The Malaysian Ministry of Home Affairs (MoHA)/Malaysian Maritime Enforcement Agency (MMEA) is the main beneficiary agency of this project, although the actions taken by the MMEA could/should also be made available to other maritime stakeholders, such as port authorities, port police, customs, and navy, under the mutual inter-agency scheme. We have no data yet on the gender.

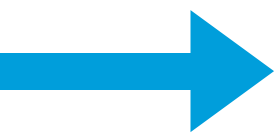
WHAT?

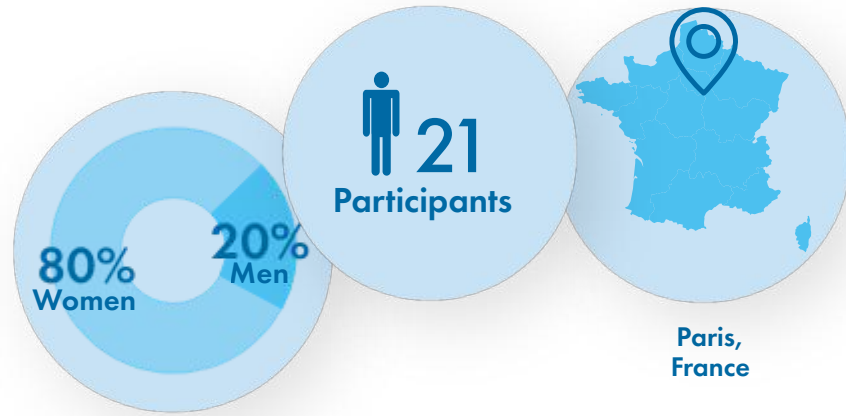

WHAT?

The Training of Military Gender Advisors addresses a critical need in peace operations. By enhancing the capacity of military components to integrate gender perspectives, it ensures the effective implementation of UN Security Council resolutions on Women, Peace, and Security. This initiative reshapes peacekeeping priorities, fostering a mindset shift within military components and bolstering Force Commander leadership capabilities.

The initiative institutionalizes gender integration across all military branches involved in peace operations, filling existing capacity gaps. Through tailored training for military gender advisors and focal points, it ensures that gender considerations are integral to the planning process at both national and international levels. Ultimately, this initiative translates resolutions into actionable steps within military operations, fostering greater inclusivity and effectiveness in promoting peace and security.
