




Alignment of UNITAR Results Areas with the Sustainable Development Goals



Introduction

Under the 2018-2021 strategic framework and biennial programme budgets, UNITAR is working to ensure that its strategic objectives and results areas are aligned with the 2030 Agenda for Sustainable Development. The 2018-2019 biennium marks the second budget cycle in which UNITAR has undertaken a 2030 Agenda alignment exercise.


The methodology used to assess programme alignment with the Sustainable Development Goals (SDGs) includes a two-step process: (i) reviewing the results areas specified in the programme budget and matching the areas to a primary SDG and target, where relevant; and (ii) reviewing the SDG indicators for the targets and assessing the extent to which UNITAR's contribution to helping Member States achieve the targets appears to be strong, moderate or weak. The SDG targets and indicators are based on the official list, which includes 169 targets and 230 indicators for the 17 Goals.¹

Under the 2018-2019 budget, UNITAR programming has links to 14 of the 17 Goals. Most result areas are associated with Goals 12 (Responsible Consumption and Production), SDG 13 (Climate Action) and 16 (Peace, Justice and Strong Institutions). Thirty per cent of the results areas are strongly aligned to the relevant primary Goal when considering the SDG indicator(s).

While UNITAR's level of output is significant (and growing), with more than 60,000 learners and an additional 25,000 individuals reached through knowledge-sharing conferences in 2018, the contribution that UNITAR is making towards helping Member States implement the 2030 Agenda is assessed moderate. This largely stems from the relatively small size of UNITAR projects on average and the lack of strong alignment when considering the SDG indicators.

This document presents the mapping between the SDGs and the UNITAR strategic objectives and programme budget results areas. The document discusses each SDG linked to UNITAR programming in turn, with the UNITAR result areas and the SDGs presented on the left and right respectively. The last column of each table indicates the strength of the link between the UNITAR results area and the SDG indicators.
